- Flex desk and Dedicated desk memberships include 4 hours of conference room use each month. Private office memberships include 8 hours of conference room use each month. ## I. Introduction

The following Service Agreement Terms and Conditions ("Agreement") are lengthy but worth reading so that you understand the terms of membership to which you agree by signing this document. If you have any questions or concerns please contact the MillWorks Co-Sharing manager at admin@millworkswestfield.com

The services MillWorks Co-Sharing provides to you are subject to the following Service Agreement Terms and Conditions ("T&C"). MillWorks Co-Sharing reserves the right to update the Agreement and any addendums at any time without advance notice to you.

You hereby represent and warrant that you have all requisite legal power and authority to enter into and abide by T&C of this Agreement and no further authorization or approval is necessary. You further represent and warrant that your participation or use of the Services will not conflict with or result in any breach of any license, contract, agreement or other instrument or obligation to which you are a party.

## II. Description of Services

Lower Mill, Inc. and Rockwell Management Corporation in management of MillWorks Co-Sharing at 77 Mill Street Westfield, MA will provide you with access to office space, furniture, workstations, wi-fi internet access, office equipment, conference space, knowledge resources, use of common areas, and other services (collectively, "Services"). The Services at all times are subject to the T&C and Rules (addendum 1) of this agreement. This Membership Agreement represents a license for the Member to use the Services, and is not intended to nor does it create a lease between the parties.

The member or tenant is permitted to use the space for the purpose of maintaining an office and performing usual office tasks while being respectful of the other members and tenants in the space. Under no circumstances will habituating the space be permitted as this is in violation of health, safety, and housing regulations. All members/tenants are expected to vacate the premises

by 10pm. Members/tenants found in violation of this rule may have their membership terminated. The space manager may allow extended hours with approval.

## III. No Unlawful or Prohibited Use

You will not use the Services for any purpose that is unlawful or prohibited by these terms, conditions and notices. This includes the unlawful use of the space as a place of residence.

You may not use the Internet Services in any manner that could damage, disable, overburden, or impair any MillWorks Co-Sharing server, or interfere with any other persons use and enjoyment of any Services.

You may not attempt to gain unauthorized access to any Services, or accounts, computer systems or networks connected to any MillWorks Co-Sharing server or to any of the Services, through hacking, password mining or any other means. You may not obtain or attempt to obtain any materials or information through any means not intentionally made available through the Services, nor should you post or download files that you know or should know are illegal or that you have no rights to.

## **IV.** Use of Internet Services

You agree that when participating in or using the Services, you will **not**:

- Use the Services in connection with contests, pyramid schemes, chain letters, junk email, spamming, spimming or any duplicative or unsolicited messages (commercial or otherwise);

- Restrict or inhibit any other user from using and enjoying the Services.
- Violate any code of conduct or other guidelines which may be applicable for any particular Service (including the Building Rules).
- Harvest or otherwise collect information about others, including email addresses, without the authorization or consent of the disclosing party.
- Violate any applicable laws or regulations; or
- Create false identity for the purpose of misleading others.

## V. Renewals and Terminations

This Agreement will automatically renew at the end of each period. Failure to follow T&C and Rules can result in non-renewal or even early termination of membership and associated privileges. MillWorks Co-Sharing reserves the right to terminate membership and any Service at any time, immediately and without notice, if you fail to comply with the T&C and Rules. This includes non-payment or violation of the space Rules and Guidelines (see addendum 1). If this happens, MillWorks Co-Sharing will refund any amounts paid for unused periods that remain after deducting any pending charges, on a prorated basis.

Members may terminate this Agreement by giving a written notice of termination to <u>admin@millworkswestfield.com</u>. A two week notice is the minimum required. Should Member not provide timely notice of termination to MillWorks Co-Sharing then the Agreement shall continue to the end of the following calendar month and the service fees for that calendar month shall be payable.

#### VI. Invoicing and Payment

Invoices are generated monthly and will include the monthly membership fee based on the membership level. The invoice will also include any variable charges that may have been incurred during the previous month. Invoices are viewable and downloadable using the membership portal. Payment is due on the first of the month and is late if received after the 10<sup>th</sup> of the month and will be subject to a late fee pursuant to the Member Rules and Guidelines. Invoice payment is set to be automatically charged to the payment method set up in the member's profile. Members can make manual payments; this must be noted at the time of joining and arrang made with the manager. Payment for casual usage is paid on the day of use unless other arrangements have been made with the MillWorks Co-Sharing manager.

All payments are processed through our website using STRIPE, a secure third-party payment processing method. ACH or credit cards are both acceptable. Once you create your membership you can add your preferred payment method to your profile.

#### VII. Confidentiality

As a member of MillWorks Co-Sharing, you may be exposed to Confidential Information. "Confidential Information" shall mean all information, in whole or in part, that is disclosed by MillWorks Co-Sharing or any participant or user of the Services, or any employee, affiliate, or agent thereof, that is nonpublic, confidential or proprietary in nature. Confidential Information also includes, without limitation, information about business, sales, operations, knowhow, trade secrets, technology, products, employees, customers, marketing plans, financial information, services, business affairs, any knowledge gained through examination or observation of or access to the facilities, computer systems and/or books and records of MillWorks Co-Sharing, any analyses, compilations, studies or other documents prepared by MillWorks Co-Sharing or otherwise derived in any manner from the Confidential Information and any information that you are obligated to keep confidential or know or have reason to know should be treated as confidential.

Your participation in and/or use of the Services obligates you to:

- Maintain all Confidential Information in strict confidence;
- Not to disclose Confidential Information to any third parties;

• Not to use Confidential Information in any way directly or indirectly detrimental to MillWorks Co-Sharing or any participant or user of the Services.

All confidential information remains the sole and exclusive property of MillWorks Co-Sharing or the respective disclosing party. You acknowledge and agree that nothing in this T&C or your participation or use of the Services will be construed as granting any rights to you, by license or otherwise, in or to any Confidential Information or any patent, copyright or other intellectual property proprietary rights of MillWorks Co-Sharing or any participant or user of the Services. All members hereby assume the risk of the Confidential Information being accessible by other Members, and each Member does hereby remise, release and forever discharge MillWorks Co-Sharing, Lower Mill, Inc., and Rockwell Management Corporation from any and all liability associated with the exposure of their Confidential Information.

#### VIII. Disclosures

MillWorks Co-Sharing reserves the right at all times to disclose any information about you and your participation in and use of the Services as MillWorks Co-Sharing deems necessary to satisfy any applicable law, regulation, legal process or governmental request, or to edit, refuse to post or to remove any information or materials as MillWorks Co-Sharing deems appropriate.

## IX. Participation in or Use of Services

You acknowledge that you are participating in or using the Services at your own free will and decision. You acknowledge that MillWorks Co-Sharing does not have any liability with respect to your access, participation in, use of the Services, or any loss of information resulting from such participation or use.

## X. Disclaimer of Warranties

To the maximum extent permitted by the applicable law, MillWorks Co-Sharing provides the Services "as is" and with all faults, and hereby disclaim with respect to the Services all warranties and conditions, whether express, implied or statutory, including but not limited to: merchantability, fitness for a particular purpose, lack of viruses, accuracy or completeness of responses, results, workmanlike effort and lack of negligence. Also, there is no warranty, duty or condition of title, quiet enjoyment, quiet possession, correspondence to description or noninfringement. The entire risk as to the quality, or arising out of participation in or the use of the services, remains with you. MillWorks Co-Sharing will makes its best efforts to ensure that the Services are not interrupted for any unreasonable period of time.

#### XI. Exclusion of Incidental, Consequential and Certain Other Damages

To the maximum extent permitted by the applicable law, in no event shall MillWorks Co-Sharing, Lower Mill, Inc., and Rockwell Management Corporation, their subsidiaries (whether or not wholly-owned), affiliates, divisions, and their past, present and future officers, agents, shareholders, members, representatives, employees, successors and assigns, jointly and individually be liable for any direct, special, incidental, indirect, punitive, consequential or other damages whatsoever including, but not limited to damages for: loss of profits, loss of confidential or other information, business interruption, personal injury, loss of privacy, failure to meet any duty, including of good faith or of reasonable care, negligence, and any other pecuniary or other loss whatsoever, arising out of or in any way related to the participation in or inability to participate in or use of the services, the provision of or failure to provide services, or otherwise under or in connection with any provision of this agreement, even in the event of the fault, tort (including negligence), strict liability, breach of contract or breach of warranty of MillWorks Co-Sharing, and even if MillWorks Co-Sharing has been advised of the possibility of such damages. to the maximum extent permitted by applicable law, even if any remedy fails its essential purpose.

#### XIII. Indemnification

You release, and hereby agree to indemnify, defend and save harmless MillWorks Co-Sharing and MillWorks Co-Sharing subsidiaries (whether or not wholly-owned), affiliates, divisions, and their past, present and future officers, agents, shareholders, members, representatives, employees, successors and assigns, jointly and individually, from and against all claims, liabilities, losses, damages, costs, expenses, judgments, fines and penalties based upon or arising out of your negligent actions, errors and omissions, willful misconduct and fraud in connection with the participation in or use of the Services. You further agree in the event that you bring a claim or lawsuit in violation of this agreement, you shall be liable for any attorney fees and costs incurred by MillWorks Co-Sharing or its respective officers and agents in connection with the defense of such claim or lawsuit.

#### XIV. Severability

In the event that any provision or portion of this T&C is determined to be invalid, illegal or unenforceable for any reason, in whole or in part, the remaining provisions of this T&C shall be unaffected thereby and shall remain in full force and effect to the fullest extent permitted by applicable law.

#### XV. Insurance

Lower Mill, Inc.'s Liability and Business Personal Property insurance does not cover your personal equipment or property while using the space. It does not cover any liabilities related to your business activities. Lower Mill, Inc. is responsible for all Common Areas including elevator, common area halls and lobby and parking lots, while Members are responsible for their own areas. As a user, you are not required but it is strongly suggested that you carry an insurance policy to cover your own equipment, personal property, and business liabilities while using MillWorks Co-Sharing Workspace. A Certificate of Insurance for Lower Mill, Inc. will be made available to you at no cost at your request.

## XVI. Compliance with Member Rules and Guidelines

All members agree to comply with the MillWorks Co-Sharing Member Rules and Guidelines as set forth in Addendum 1. Failure to comply with these guidelines may result in termination of your membership and access to Services.

## XVII. Notice

Notice. All notices, requests, demands or other communications for which this T&C provides shall be in writing and shall be addressed at the following addresses:

All notices under this T&C, shall be effective: (a) forty-eight (48) hours after deposit in the U.S. Mail, postage prepaid, registered or certified mail, return receipt requested; (b) Upon delivery, if delivered in person to the address set forth above; or (c) upon delivery, if sent by commercial express service, such as Federal Express, except that notices of change of address shall be effective upon receipt.

## XVIII. Waivers

No waiver shall be binding on MillWorks Co-Sharing unless executed in writing by an authorized representative of MillWorks Co-Sharing.

## Addendum 1

## MillWorks Co-Sharing Member Rules and Guidelines

MillWorks Co-Sharing is a collaborative, supportive, and professional community. In the interest of sustaining and maintaining this community and the members that it supports; all members must abide by the following rules and guidelines.

- 1. An active MillWorks Co-Sharing Membership is required to use any of the spaces or Services described here-in. Exceptions are limited to:
  - Day Pass holders,
  - Clients or guest of MillWorks Co-Sharing members with scheduled meetings or appointments, provided the Member is present.
  - Non-member attendees of events at the space, provided that the Member who reserved the space and is hosting the event is present.
- 2. All memberships are month-to-month with the exception of those private office space members that have negotiated a longer-term commitment. Month start date is 1<sup>st</sup> of the month, the end date is the last day of the month.

For memberships starting mid-month the fees will be pro-rated accordingly.

A 14-day notice is required for month-to-month members to terminate their membership. For members with longer commitments, a 30-day notice must be submitted if the member does not wish to renew the agreement. All termination notices should be emailed to admin@millworkswestfield.com.

- 3. Monthly Membership Fees. Monthly membership fees are due on the first day of each month. Payment is late if received after the 10th of the month, a \$25 late fee will be applied on the 11th. Payment is automatically charged to the payment method set up by the member in the member's profile. Any problems with the payment method must be resolved prior to the 5<sup>th</sup> to avoid the \$25 late fee. Members can make manual payments; this must be noted at the time of joining and arrangements for invoicing and payment made with the space manager.
- 4. The member or tenant is permitted to use the space for the purpose of maintaining an office and performing usual office tasks. Under no circumstances will habituating the space be permitted as this is in violation of health, safety, and housing regulations. All members/tenants are expected to vacate the premises by 10pm. Members/tenants found in violation of this rule may have their membership terminated. The space manager may allow extended hours with approval.
- 5. All payments are processed through our website using STRIPE, a secure third-party payment processing method. ACH or credit cards are both acceptable. Once you create your membership you can add your preferred payment method to your profile.
- 6. Members cannot sublease space nor resell any services already offered and sold by MillWorks Co-Sharing. This includes, and is not limited to, sharing, gifting, or reselling office space, desk space, conference room, or event space hours.

- 7. MillWorks access codes for the building and wi-fi are not transferable. You are not authorized to copy or to give or "loan" your access code to anyone else for any reason. If this rule is violated your membership may be cancelled.
- 8. Guests. A guest is defined as a person or persons that are visiting a member for a period not to exceed one workday, with the Member present.
- 9. Noise Level. Members will maintain a noise level that is respectful of others and will permit all members to work without disturbance.
- 10. Members shall not place anything in the common areas, hallways, doors, windows, or any other surface or place that is visible by members without prior approval from the space manager.
- 11. Members/Tenants shall not paint, install permanent shelving or other fixtures, or in anyway alter the space without the approval of the property manager. Members/tenants in violation of this rule will be billed for expenses to remediate damages.
- 12. Members will keep hallways, passages, exits, entrances, and stairways free from obstructions at all times.
- 13. Reserving conference rooms and the event/presentation room. The member room booking portal is used to reserve dates and times for these rooms. Please be respectful of schedule times and book ample time for your meetings so that you don't run over into another member's time slot. It is recommended to leave at least 15 minutes between meetings to allow time for cleanup. Member room credits do not roll over from month to month and cannot be sold or gifted to others.
- 14. Kitchenette(s) and Common Areas. All members are asked to help to keep these areas neat and tidy. Please clean up after yourself; toss the coffee cups, clean spills, use the vacuum if you make a mess. Please report any major issues (heat or a/c issues, floods, leaks, bathroom back-up, etc.) to the building maintenance staff. This number is posted in the larger kitchenette area.
- 15. Refrigerator rules: Feel free to store food or beverages in the refrigerator. Please don't eat anyone else's food or drink their drinks. Label your things with name and date. Toss your leftovers before they get stinky and green. Storage of alcoholic beverages is not permitted.
- 16. No cooking is allowed in the MillWorks Co-Sharing space. Use of the microwave, coffee pot, and electric kettle is permitted.
- 17. Please honor and respect the boundaries of all members. While socializing is a perk of a cosharing space, most are here to get stuff done – please be mindful of that.
- 18. Internet Guidelines. Internet access included with memberships is through a wi-fi network managed with a Meraki access points. Access to the wi-fi network is granted through the membership portal. All private office spaces have Cat6 Ethernet cable available. Private office members have the option of contracting directly with Whip City Fiber for direct ethernet internet access. These members will be responsible for all fees related to this service and all contractual obligations with Westfield Gas and Electric/Whip City Fiber.

You may not assign your login name, password or IP address to any other person. You agree not to use the Service, any MillWorks Co-Sharing or related network or website for any fraudulent, unlawful, harassing or abusive purpose, or so as to damage or cause risk to our business, reputation, employees, subscribers, facilities, or to any person. Improper uses include, but are not limited to:

- Violating any applicable law or regulation;
- Posting or transmitting content you do not have the right to post or transmit;
- Posting or transmitting content that infringes a third party's trademark, patent, trade secret, copyright, publicity, privacy, or other right;
- Posting or transmitting content that is unlawful, untrue, stalking, harassing, libelous, defamatory, abusive, tortious, threatening, obscene, hateful, harmful or otherwise objectionable as determined in our sole discretion;
- Attempting to intercept, collect or store data about third parties without their knowledge or consent;
- Deleting, tampering with or revising any material posted by any other person or entity;
- Accessing, tampering with or using non-public areas of the Service or any MillWorks Co-Sharing Space or related website, computer systems or network;
- Attempting to probe, scan or test the vulnerability of a system or network or to breach security or authentication measures;
- Attempting to access or search the Service or any MillWorks Co-Sharing or related network or website with any engine, software, tool, agent, device or mechanism other than the software and/or search agents provided by MillWorks Co-Sharing or other generally available third-party web browser;
